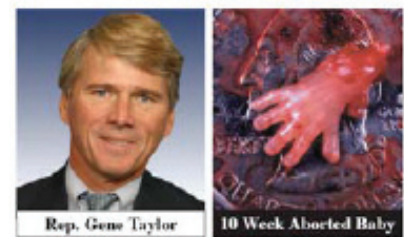

I am writing to ask for your help. The money we are spending on this emergency project was not budgeted, but this is a once-in-a-generation opportunity to block legislation which would cause the deaths of countless preborn babies. It would create a foundation on which its architects would build a thoroughly European killing system which would make abortion and infanticide and euthanasia, etc. impossible to even contest.

The U.S. Catholic Bishops oppose this bill because, as noted by the Diocese of Kansas City, ObamaCare would allow federal funds to be used for elective abortions, federal funds would subsidize health plans which cover abortion and Americans who are morally opposed to abortion would be forced to pay for abortions. FoxNews.com, March 12, 2010, published a story headlined "Stupak Claims Committee Chairman Wants Government to Fund Abortions."
