# Abortion Pills are Now Another Way for Men to Force Abortions on Women

*Pro-abortion Boyfriends are Assaulting Women and some Pro-lifers Want to Punish Women*

**T**his week, we learned of another boyfriend who caused the death of a preborn baby, and the baby’s mother is also dead. The *Organiser* in India reports:

The mysterious death of a 19-year-old nursing student in Varanasi’s Sarnath area has taken a dramatic turn with the arrest of one Mohammad Sameer. Police allege that Sameer forced the student, who was around three months’ pregnant, to consume abortion pills, leading to excessive bleeding and her eventual death. The victim, a second-year General Nursing and Midwifery (GNM) student, was found in a critical condition on the staircase of a boys’ hostel on Wednesday. She was rushed to a nearby hospital, where doctors declared her dead. <https://bit.ly/4uBWmgY>

Sameer allegedly learned about how to abort this baby [his?] by watching videos on YouTube.

It is not just boyfriends who are forcing women to take abortion pills. A father in Ohio held his daughter down in his attempt to force her to take an abortion pill. Police received a call on May 28, 2026, with this allegation. <https://bit.ly/3QgN7ox>

Susan B. Anthony Pro-Life America and Heartbeat International maintain lists of “abortion pill poisonings”, and this violence is growing as abortion pills are obtained by men.

Abortion pills are being sent in the mail without any consultation with a doctor, and this has resulted in yet another means that men (and parents) can force their will on pregnant women. It is easier to surreptitiously get the pregnant woman to take an abortion pill than it is to drag her into an abortion mill. This sort of assault is also being facilitated by the pro-abortion advocates who are encouraging the use of misoprostol to expel the baby

without first taking a mifepristone pill to kill that baby. Misoprostol pills are easier to obtain and less heavily regulated, but “medical” abortions without taking both pills are even more dangerous for women than the two-pill regimen. It is obviously easier to trick or coerce a woman into taking one pill than two, but pro-abortion activists appear to care more about advancing their political agenda than protecting women.

Disturbingly, growing numbers of people who claim to be “pro-life” are encouraging more abuse of women. The topic of punishing women who abort is again rearing its ugly head.

On May 4 and 5, we were invited to have a prenatal science exhibit booth at NIFLA’s Leadership Summit. National Institute of Family & Life Advocates invited key attorneys and physicians with whom we want to collaborate, so CBR Executive Director Gregg Cunningham was in a session which featured a panel that addressed the question of whether women who have had abortions should be

criminally punished. To our knowledge, this topic has not been addressed at a national conference.

There was no one else besides Mr. Cunningham at the summit who had served as a state legislator, and who had sponsored legislation limiting elective abortion. With hard work and with God's grace, The Pennsylvania Abortion Control Act was passed into law in 1982. If a clause had been inserted in the bill to punish post-abortive women, the entire bill would certainly have been defeated and countless savable babies would have been lost.

CBR believes those pushing punishment are deeply misguided, and we have written about our stance. It is worth reprinting excerpts from the June 2021 CBR Communiqué. [Following]

Prior to the legalization of abortion in the United States, no woman was ever successfully prosecuted for having an abortion. Marvin Olasky, in his book *Abortion Rites*, wrote that his research unearthed only one woman who was prosecuted for an abortion, and her case was ended without criminal penalties.

American feminists in the 18th, 19th and early 20th centuries fought for basic rights such as the right to vote, the right to own property, and the right to shared custody of their children if divorced. They called abortion "child murder." Many of these women were Christian leaders who saw abortion as another means for men to dominate and exploit women. Susan B. Anthony gave a speech in 1875 entitled "Social Purity," and in it she compared abortion and infanticide to rape and prostitution, referring to all four practices as male wrongs against women...

There is a powerful passage in Miss Anthony's article in the feminist newspaper *Revolution* entitled "Marriage & Maternity": "Guilty? Yes, no matter what the motive, love of ease, or a desire to save from suffering the unborn innocent, the woman is awfully guilty who commits the deed. It will burden her conscience in life, it will burden her soul in death; but oh! thrice guilty is he who, for selfish gratification... drove her to the desperation which impelled her to the crime." <https://bit.ly/4xvmRr3>

On the other hand, pro-aborts would LOVE it if pro-life people became known as advocates of criminal penalties for women who abort. This sort of philosophy would only make pro-lifers seem like heartless fools. Nearly one-

quarter of American women have had abortions ( <https://bit.ly/43DDnYt> ), yet huge numbers of them are coerced into doing so by boyfriends and husbands and other family members. Attempting to assign degrees of culpability would be impossibly complex and would lead to virtually no convictions. Nor would any of this have any deterrent effect ... A big question that is not raised by people who call for criminal penalties for women is what about the men who got them pregnant? This is pure hypocrisy.

Finally, and most importantly, how would Jesus respond to women who are living in the aftermath of their abortions? John 8:3-12 records the incident where a woman caught in adultery was brought to Jesus by the scribes and Pharisees. They challenged Him with the Mosaic Law and reminded the Son of God that such acts should result in stoning her. These hypocrites asked our Lord, "What do you say?" Jesus responded by stooping down to write on the ground. When they persisted in asking him, Jesus rose up and said, "He who is without sin among you, let him throw a stone at her first." Once again, Jesus stooped down and wrote. The religious rulers began to leave one by one, beginning with the older ones. When only the woman was left, Jesus straightened up and asked her, "Woman, where are those accusers of yours? Has no one condemned you?" She responded, "No one, Lord," and Jesus said to her, "Neither do I condemn you; go and sin no more."

It is not prudent to call for criminal penalties for women who abort. It is the abortionist who should be punished. Women need education about the preborn baby and what abortion does to him. If they abort, they need to know there is a Savior who is as eager to forgive abortion as any other sin of which they repent.

Baranov is the founder of St. John the Forerunner Orthodox Pro-Life Society in New York, but he initially began pro-life ministry in his native Russia. While a university student, he organized his first pro-life action in 2006 in Tomsk, Russia. Baranov bravely used CBR photos in the public square.

Unfortunately, no other pro-lifer was present when Baranov arrived prior to an Orthodox prayer service. Police did not arrive until the prayer service ended. Led by Fr. Micah Breland, a priest of the Orthodox Church in America, the service was a moleben for the end of abortion. “A Moleben is a service of prayer in which the Church asks God for help, mercy, or blessing in a particular situation.” <https://bit.ly/3SagJ7z>

Baranov is an admirable activist and he needs our prayer, especially as New York has become more lawless.
